- 5. All remarks shall be addressed to the Council as a body and not to any member of the Council or Staff.
- 6. Public members recognized by the presiding officer, shall:
 - a. Stand, if able
 - b. For the record, give his/her name and address
 - c. If applicable, give the person, firm or organization he/she represents
 - d. Limit comments to the matter of fact
 - e. Address the Council as a body and not to any individual member of the Council or City Staff
 - f. Ask no questions of individuals who are Council members, staff or other public members, except through the presiding officer
 - g. Limit comments to a maximum of 5 minutes, unless such time is extended by a majority vote of Council members.

MINUTES OF THE PARK & RECREATION COMMITTEE

February 23, 2021

In attendance: Gary McDermott, Pat Frydenlund, Lyle Kimmet, Jason Gray, Luis Correa, guests Ariel Weishaar; Brook Weishaar and Brittany Blair and Lorette Carter.

Civic Center:

City Facilities:

- Building maintenance: Rob Tasker continues to work on restoring the bleacher sections and stair railing. When the lockers are finished, he will install them in the main hallway into the gym as well as coat hooks.
- Ariel and Brook reported Hi-Fit classes are going well and numbers are picking up particularly.
 Thursday evenings.

In general discussion of the Civic Center the following items were discussed:

- Parents are concerned with the location of the kid's room. They voiced concern for lack of
 visibility and the heat that is produced when the door is closed. Suggestions included moving
 the kid's room to the spinning room; or converting the door to a Dutch-door to keep kids in the
 room but allow air movement and installing a camera system which parents could watch kids in
 the room.
- Parents also suggested the City purchase new toys for the kid's room. Many of the toys are old
 and broken. They also would like to ask for a TV in the kid's room.
- Parents also asked about installing an electronic adapter for the TV in the gym in which to
 upload apps for kids and families to exercise and play active games on the gym floor.
- It was also suggested that a system be worked out to allow adults to access walleyball net/ball
 and basketballs during hours when the office is not staffed. One idea was to put those items in
 a locked locker and an adult would have to get the combination to access. The adult would be
 responsible for those items.
- The parents also discussed the cost to bring their kids when they do not have family passes.
 They thought there should be some age minimum like 5 years old to charge the day fee,
 especially given there is not always access to the kid's room and there is not a lot for little kids to do.
- One parent suggested the City consider taking out a portion of the south bleachers to create a room for fitness classes.

Roadrunner Recreation Trail: The application for Montana FWP Urban Trail Program funding for the single-track mountain bike trail has been submitted. Funding notification should be published in late spring. The City crew continues to sweep the trail to allow for usage year-round.

Krysko Skate Park: The application for funding from the Montana State Parks Land Water Conservation Fund has been submitted. Funding notification should be announced in April. Ariel asked about the design and need for additional concrete sections as the bowls will be crowded with kids biking, riding scooters and skaters. Jason offered to create shade structures within the Skate Park this spring. Ariel

and Brooks noted their nephews got stuck in the bowls during the snowy weather. They suggested some sort of rope ladder. The City will be installing a camera at the Park soon which could help.

Swimming Pool: Luis reported a new diving board will be installed at the Swimming Pool this spring.

Historic Shelby High: Luis reported work continues in the gym. Shannon McAllister has spearheaded the volunteer efforts to improve the facility. Sheetrocking should be completed soon and gym wall pads installed. The next project for the City is re-roofing of the building to preserve and protect its integrity.

Tree Board:

Agreements have been finalized for the forestry funding sources. Bid solicitations have been sent to area tree arborists and nurseries for the removal of 10 green ash trees on the Bitterroot School property and Historic Shelby High property and 14-15 new tree species planted in the Skate Park, Meadowlark Park and other areas within the community this spring.

With no further business, the next meeting is scheduled for Monday, March 29, 2021.

WHEREAS, the purpose of the International Energy Conservation Code is to provide minimum requirements for the design of new buildings and structures and additions to existing buildings, regulating their exterior envelopes and selection of their heating, ventilating, air conditioning, service water heating, electrical distribution and illuminating systems, and equipment for effective use of energy, pursuant to 24.301.161 (2), ARM; and

WHEREAS, the City automatically adopts the Department of Labor's codes including the 2018 Energy Conservation Code pursuant to Shelby Municipal Code 10-1-1, Adoption of Model Building and Technical Codes by Administrative Action; and

WHEREAS, the Department of Labor and Industry now requires the City to specifically adopt the 2018 International Energy Conservation Code by resolution.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHELBY, MONTANA;

That the International Energy Conservation Code, pursuant to Department of Labor and Industry administrative rule 24.301.161, ARM and Shelby Municipal Code 10-1-1 is hereby adopted and incorporated into the City's building codes.

Dear Gary and Jade:

The City of Shelby, Montana (the "City") intends to borrow funds to finance the costs of a wellfield expansion and improvements to the water treatment plant (the "Project") that forms a part of the City's water system (the "System"). It is anticipated that the City would obtain financing for the Project from the State's Drinking Water State Revolving Fund Loan Program (the "Program"). We have enjoyed working with the City in the past and will be pleased to serve as bond counsel in connection with the issuance by the City of its approximately \$1,035,000 Water System Revenue Bonds (DNRC Drinking Water State Revolving Fund Loan Program), expected to consist of a \$500,000 Subordinate Lien Taxable Series A Bond (the "Series A Bond") and a \$535,000 Series B Bond (the "Series B Bond" and, together with the Series A Bond, the "Bonds") to pay a portion of the costs of the Project and related costs. The purpose of this letter is to outline the services we would provide in that capacity and provide a fee estimate in connection with the issuance of the Bonds.

As bond counsel our principal function is to render an opinion with respect to authorization and issuance of the Bonds. The opinion is rendered in written form at the time the Bonds are delivered to the DNRC. The opinion would be addressed to the DNRC (as purchaser) and the City, and both parties are entitled to rely on it. The opinion with regard to the Series B Bond addresses three basic matters:

- the validity of the Series B Bond, based upon the proceedings taken in its authorization and issuance;
- certain matters relating to the security for the payment of the Series B Bond; and
- 3. the exemptions from current federal and state income taxation of the interest payable on the Series B Bond.

In our capacity as bond counsel we would provide the following services to the City:

- prepare the bond resolution and the Bonds and review proceedings of the City relating to other outstanding bonds and notes secured by the net revenues of the System, if any;
- review water rates and charges to confirm that rates and charges are in effect at
 the time the Bonds are issued to provide adequate revenues to pay the costs of
 operating and maintaining the System and to pay debt service on the Bonds
 consistent with the Program requirements;
- coordinate with the City Clerk-Treasurer, or other designated officer of the City, the adoption of resolutions and other actions necessary to be taken by the governing body of the City;
- 4. advise the City of the statutory requirements for the issuance of the Bonds and the Program rules for the purchase of the Bonds by the Program;
- 5. prepare closing papers for the City and supervise closing on the Bonds; and
- 6. deliver the opinions discussed above to the City and the DNRC.

The fee for our services is a function of the size of the bond issue and the amount of time expended. There is a minimum amount of work that has to be done irrespective of the size of the bond issue. We estimate our fee would be approximately \$15,000. If, as we proceed, we discover factors that are currently unanticipated that would cause us to exceed this estimate, we would let you know. We would expect to be paid at the time of closing on the Bonds. Our fees are eligible costs of the Project and can be included in the amount of the Bonds. It is mutually understood that the services set forth in this letter are solely for the benefit of the City.

You should be aware that we have served as bond counsel to the State with respect to establishing the Program and the issuance of the State's general obligation bonds to fund the Program. As bond counsel for the City's Bonds, we would not represent the State or the DNRC in the negotiation of the terms of the Bonds, the bond resolution, or other aspects of the proposed financing. At this point, the terms of the financing have been established in the approved Program documents and regulations, and our principal task is to draft a bond resolution that conforms to these requirements and the terms of the commitment letter that will be prepared by the DNRC. (In advising the City of the statutory and other legal requirements for the issuance of the Bonds, in accordance with provisions of the commitment letter, the trust indenture governing the Program, and statutory provisions, we can advise the City with respect to the legal implications of the covenants in the commitment letter, the trust indenture governing the Program, and statutory provisions that would be contained in the bond resolution.) Accordingly, we do not anticipate that our acting as bond counsel to the State with respect to the Program will present any practical impediment to our acting as bond counsel to the City with respect to the Bonds; and, in fact, we believe our familiarity with the Program could be an advantage to the City in completing its proceedings efficiently.

As bond counsel to the State and the Program, however, we are available to the State, and we would intend to respond to questions raised by the DNRC regarding requirements of the Program, the operative documents relating to the State's bonds and the legal issues relating to the type of obligation being purchased by the Program to evidence the Program loan, in this case a revenue bond. In such a response, we would not attempt to advocate a position on behalf of either the State or the City, but to respond in our capacity as bond counsel with respect to the State's outstanding bonds. While we would attempt to render independent advice, the potential for a conflict of interest or the appearance of a conflict of interest is present. The State has consented to our acting as bond counsel for the City's Bonds.

We hope that this proposal to serve as bond counsel on this financing meets with the approval of the City, and we trust that our serving as bond counsel to the City and as bond counsel to the State with respect to the Program is acceptable to the City. If so, will you please so acknowledge by signing the attached acknowledgment and returning a copy to us. If there are any questions, please give us a call so that we might answer those questions or provide any additional information about our firm or our qualifications to serve the City in this capacity.


