Montana Historic Preservation Grant Opportunity

The mission and goal of the City of Shelby is to provide a quality of life for all residents that supports the ideals of the community in honoring and preserving the past while welcoming a progressive future. Preserving the historic Shelby Town Hall while continuing to maintain the building as a public facility serves to meet these community goals.

Shelby Town Hall has served the community for nearly 100 years. Built in May of 1923, Shelby Town Hall was built in less than 2 months in anticipation of the droves of fight fans and media who would be flocking to Shelby for the infamous World Heavyweight Championship Fight of 1923. The building was quite modern considering the streets were dirt and sewer and electric lines were just being laid in the community.

Through the twentieth century the building served the local government needs of the town and center of political activity. October 17, 1938 council minutes record a WPA Project to remodel the original 1923 building. The project included tearing out interior partitions to make one large room; build a small storm vestibule around the outside of the front door and repair the roof. In 1999, the Shelby City Council approved the installation of a ramp in compliance with ADA accessibility standards, moving the main entrance door to the south side of the storm vestibule.

In order to maintain the original architectural style, city officials have since replaced some front windows with modern replicas of the original windows and created faux window and door frames that reflect the original style of the entrance into Shelby Town Hall.

In 2021, the City of Shelby received Montana Historic Preservation Program funding to resurface the roof of the historic building. Most recently the city was awarded MT Office of Tourism funding to repair and repaint the exterior of Historic Shelby Town Hall, further working to preserve the original character and extend the life of this historic building, showcasing the City of Shelby's 1923 progress and prosperity.

The application to the 2022 Montana Historic Preservation Grant Program will seek funding as the match requirement to the Montana Office of Tourism grant and add additional work to re-install small windows on the vestibule, reflecting the original architectural style.

Maintaining and improving the exterior of the structure will ensure the Chamber/VIC office will remain open and viable – welcoming travelers annually who shop, eat and stay in Shelby.

TRANSIT UPDATE 12.27.21

Ladies and Gentlemen,

Happy Holidays to all of you! Since our last TAC meeting held last month, we have been very busy at the transit. We received our grant allocations from the FTA/MDT. I am proud to say we will be receiving the most funding I have seen since my interim. Northern Transit Interlocal is allocated \$105,964 for Fiscal Year 2023. This is \$13, 821 more than a year ago. Toole County Transit Combined (TC Transit, GC Transit, & PC Transit) is allocated \$105,182. This is \$13,719 more than a year ago. Toole County Transit was also allocated \$12,005, this is \$7,783 more than last year as well. \$35,323.00 total increase for operations for Fiscal Year 2023!

MDT and FTA inspectors visited our facility and were more than impressed with our lay out, cleanliness and organization. They took some pictures and asked me to right up a Facilities maintenance plan (on the extra time I don't have) for use in education for other rural transits. All of us should feel proud of the way our transit operates. MDT would like me to host an educational meeting this Spring at our facility. I know it will take more of my time to assist them, but I still feel confident it will not interfere with daily transit operations.

We have already began preparing for the coordination plan and grant submission that is due on March 31st, 2022. Had a few employee issues that I did discuss with Mary Ann and was able to get handle without any further issues. Other than that, ridership has been excellent, everyone is working hard. Very, very busy the next few months. Like always if any of you have any questions please let me know.

Also attached is a graphic that shows where all our reservations on our website are coming in from. Since we launched the new reservation system in late September, we have received 194 confirmed reservations and more of our regular riders are beginning to see the ease of making reservations on our website. The graphic shows where all the reservation requests have come from, not only in the US and Canada but all over the world!
